LIFESPAN RESOURCES 2024 HIGHLIGHTS AND ACHIEVEMENTS

Over Fifty Years of Service in southern Indiana!

Voice and Vino at the Casino: Season Seven!

Season Seven of our premier gala fundraiser was held on October 1, 2024, once again at Caesars Southern Indiana to a packed house. Guests were entertained by 6 singing acts, including 3 duets. The event was voted Best Charitable Event by the readers of the News and Tribune. Congratulations to Fancy Fulton-Smith and Keri Duncan, Duet Winners. And, congratulations to Richard Ryan, Individual Winner.

In Home Services and Aging and Disability Resource Center (ADRC) Highlights:

2024 brought a year of change to our agency as we transitioned from Case Management of Medicaid Waiver clients to Service Coordination under the new state managed care program: Pathways for Aging.

- Successfully contracted with two managed care entities (MCEs) to continue service coordination for many of our clients under the new Pathways for Aging program.
- Expanded into 7 additional counties for Pathways Service Coordination: Perry, Crawford, Lawrence, Orange, Washington, Jackson and Monroe
- Held our 6th annual vendor fair allowing our staff to learn more about the local service providers caring for our clients. Forty service providers participated.
- Implemented the Aging Brain Care Dementia Care Coach Program to local persons living with dementia and their caregivers.
- Two management team members received Inform USA Information & Referral Certification

Senior Games

Seniors were transported to France this summer with the 38th Annual Senior Games. This year's theme was Summer in Paris... Oh! La La! The games occurred June 3-7, 2024 and raised over \$48,000! At the closing ceremony, the queen and king were announced: Queen - Theresa Simmons & King - Jeff Bridges

Nutrition and Wellness Highlights:

- Opened our first new congregate center in over 10 years in an underserved part of our service area: Jefferson Park in Jeffersonville.
- Expanded the Produce for Better Health Program by delivering 2,082 boxes of fresh produce to 126 congregate clients. Provided 14,574 pounds of produce.
- 3. Added evidence-based health and wellness programs Stepping On, a falls prevention program; and Bingocize, which offers health education and exercise.
- 4. Added Dementia Outreach program including Dementia Live hands on workshop.

Transportation Highlights:

- Contracted with managed care transportation broker, LCP, allowing us to save many clients from having to find alternative medical transportation.
- Signed contract with Lake Pointe Village allowing us to transport more clients in Scott Co.
- All drivers completed hands-on training provided by RLS and Associates (RTAP). All passed written and hands on experience tests.

Marketing, Fundraising and Community Outreach Highlights:

- 1. Held 38th Annual Senior Games Oh! La La, Summer in Paris Theme –completed our week long event in June with 180 participants and \$48,000 sponsor dollars.
- 2. Kicked off our new name for the Senior Games Gang, which is now the Senior Games Squad. Added new members to a total of 130.
- 3. Held Voice and Vino Season 7 Brought in over \$115,000 and included a new 50/50 raffle and an auctioned guitar signed by Taylor Swift that sold for \$3,000. Also new this year: Three live client testimonials on stage.
- 4. Expanded annual holiday gift program, the Senior Angel Tree to 100 clients.
- 5. Developed new planned giving program, LifeSpan Resources Legacy Circle; launched quarterly planned giving newsletter, Partners.
- 6. LifeSpan Resources once again voted Best In Home Assistance Agency, Best Disability Service Provider and Best Charitable Event (Voice and Vino) by the readers of the News and Tribune.
- Successfully completed memorabilia scanning project in partnership with the Floyd County library. Nine scrapbooks of historical
 memorabilia were scanned into the library's Indiana History Room database, thereby preserving priceless pieces of our 50-year
 history.

HR, IT and Fiscal Department Highlights:

- 1. Implemented new Payroll System, Paylocity, with electronic timecard capabilities, enhanced compliance, electronic on-boarding, and a host of additional resources that will be explored.
- Contracted with new HR Vendor, Puzzle HR, to assist with recruitment, strategic planning, employee satisfaction, on-boarding, exit and stay strategies, HR Compliance, Leave and Benefit Management, Labor Law, Job Descriptions, Performance Evaluations, Handbook and Supervisor Manual administration, Employee Coaching and more.
- 3. Ended the FY24 \$1.9 million in the black with NO audit findings, despite mountainous challenges and banking obstacles.
- 4. The Rev. Tony Toran, was named the new President of the LifeSpan Resources Board of Directors.
- 5. CEO of the past 7 years, Lora Clark, announced her retirement in March 2025. Her many accomplishments include eliminating wait lists for direct services, creating the popular Voice and Vino gala, and expanding community awareness of LifeSpan Resources. Lora presided over the most profitable years in our agency's history.
- 6. Meredith Lambe, named new CEO as of January 2025, becoming our 5th agency leader in our fifty-one year history.

ADVOCACY AND OUTREACH

We represent senior citizens in many ways in our community through membership in human services organizations and state and national networks. We also sponsor the annual Senior Games (including Nursing Home Games), the Golden Hoosier Volunteer Award, the Senior Angel Tree Holiday Program, and the Senior Games Squad membership program.

Lifespan Resources offers this trusted and FREE local resource where people can turn for unbiased information and referral to a wide array of long term support options. Our trained Options Counselors are in person, by phone, or by appointment.

11,297 interactions were made through the ADRC. 846 interactions with Options Counseling.



CASE MANAGEMENT/SERVICE COORDINATION

Lifespan Resources serves as the single entry point into a variety of supportive services for older adults and individuals with disabilities to remain independent. Our state certified and highly trained case managers and service coordinators identify needs, link clients with home and community-based services, and create person-centered care plans.

3,456 clients received Case Management for a total of 46,832 hours of service provided.

We coordinate many in-home services that allow our clients to remain living safely in the homes they cherish. These services include:

COMMUNITY-BASED CARE TRANSITION PROGRAM

Our Managed Care Options Counselors work closely with the patients' nurse case managers to educate patients and connect them to resources needed for safe transitions from hospital to home.

221 patients received Care Transition services.

Daily programs include health and wellness programs, nutrition education and many fun socialization activities including arts and crafts, cards, games and puzzles, bingo, music and much more. FAMILY CAREGIVER PROGRAM

This program connects caregivers to community resources particular to their needs including Respite Care, Caregiver Education and other supportive services

10,461 units of service were provided for Family Caregivers.

NUTRITION PROGRAM – MEALS-TO-GO

LifeSpan Resources Meals to Go! program provides weekly delivery of seven-meal boxes to people who are

homebound, who no longer cook, who have no family members to provide groceries, can't afford to buy enough food, live in food deserts, or encounter other barriers. Meals are planned by a registered dietitian to be well balanced and tasty; and provide 1/3 of the daily dietary requirements.

54,055 meals provided through Meals to Go!

TRANSPORTATION / RIDES-TO-GO

We offer several transportation programs including medical and social transportation and transport to adult day programs. All vehicles are equipped to transport individuals in wheelchairs safely and comfortably. All drivers are background, drug and alcohol tested, CPR and first aid certified, and trained in safe transport.

5,250 medical trips were provided. 13,533 social trips were provided. 18,783 total trips were provided.



PRODUCE FOR BETTER HEALTH

This innovative new program offered in partnership with IAAAA, the Anthem Foundation and Indiana University, provides bi-weekly boxes of fresh produce to our congregate clients to take home and enjoy. This is a "Food as Medicine" program that researches the health effects of consuming more fresh produce.

126 clients served. 2,082 boxes of fresh produce provided. 14,574 pounds of produce provided.

PREVENTATIVE HEALTH

Health screenings, nutrition education programs, music, arts and crafts, games and a host of other socialization activities, along with evidence-based wellness programs are offered throughout the year at our congregate centers and other community locations.

241 health screenings provided.

1,536 units of evidence-based wellness programming provided. 15,232 units of nutrition education and socialization provided.
